### Statement of insolvency of Bank Gospodarstwa Krajowego

*To everyone who may be concerned by the above-mentioned issue*

According to information gathered - the unauthorized Management Board of Bank Gospodarstwa Krajowego, owned by the Polish State Treasury, decided to indebt Poles on the Luxembourg Stock Exchange for the amount of EUR 25 billion, i.e. approximately PLN 100 billion, preparing to issue bonds - allegedly on behalf of the Polish Nation and the Polish State. It appears to be fraud and abuse by members of the BGK management board. Because in order for Bank Gospodarstwa Krajowego to do anything, it must have authorization from the Prime Minister, and we have no information that Donald Tusk has signed such document that would authorize BGK to carry out the planned issue.

In connection with the above, as the head of the Sovereign National Government of Poland, I declare to all and sundry that neither the Polish state nor Polish taxpayers will pay any interest on the bonds issued by BGK, nor will we purchase them back.

I call on the Internal Security Agency to deal with the Members of the Management Board of Bank Gospodarstwa Krajowego in order to clarify the above issue and block the possible theft from the Polish taxpayer's pocket in the amount of PLN 100 billion plus interest.
